

The COVID-19 virus is an infectious disease with potentially serious consequences. At events held and sponsored by Jonathan Mehrian and his participating Senior Marketing Directors, participants must follow applicable local safeguards to help reduce the risk of spread of COVID-19, such as physical distancing and the wearing of face coverings. However, Jonathan Mehrian and his participating SMDs cannot guarantee that its participants, partners, or others in attendance will not be exposed to or become infected with COVID-19 or otherwise suffer injury or loss.

By agreeing to this COVID-19 Event Waiver ("Waiver"), the Participant agrees:

1. Participation in events held or sponsored by Jonathan Mehrian is voluntary.
2. Participant represents and warrants that at least one of the following applies: (a) Participant has been fully vaccinated against COVID-19 (defined as two (2) weeks after the second dose of a two-dose series or two (2) weeks after a single dose vaccine); (b) Participant has received a negative COVID-19 test result within three (3) days of start of the event.
3. When participating in the event, Participant will comply with all safety and social distancing protocols of the event and, if applicable, the facility hosting the event.
4. Participant will not participate in the event if he/she has within the past fourteen (14) days: (a) experienced any symptoms associated with COVID-19, which include fever, cough and shortness of breath among others; (b) traveled internationally to an area that has experienced or is experiencing sustained community spread of COVID-19.
5. Participant will self-monitor for signs and symptoms of COVID-19 and contact their SMD if he/she experiences symptoms of COVID-19 within fourteen (14) days after the event.
6. COVID-19 is contagious, and Participant understands it is the sole responsibility of Participant to evaluate carefully all risks inherent in participating in the event. Participant voluntarily assumes full responsibility for the risk that Participant may be exposed to or infected with COVID-19 through his/her participation in the event and that such exposure or infection may result in personal injury, illness, permanent disability, death or other damages or expenses.
7. The risk of becoming exposed to or infected with COVID-19 during the event may result from actions, omissions, or negligence of Participant or others, including, but not limited to, Jonathan Mehrian and its affiliated partners and sponsors, including his directors, officers, employees, volunteers, and agents.
8. Participant voluntarily assumes all of the foregoing risks and accepts sole responsibility for any injury to Participant including, but not limited to, personal injury, disability, death, illness, damage, loss, claim, liability, or expense, of any including claims unrelated to COVID-19.
9. Participant releases and agrees to hold harmless and indemnify Jonathan Mehrian and its affiliated partners and sponsors, including the directors, officers, employees, volunteers, and agents (collectively, the "Released Parties") from any and all liability, arising from negligence or otherwise, and any damages that may result from Participant's participation in the event, including but not limited to property damage and any mental or physical bodily injury, including death, even if not related to COVID-19.

10. This release includes any Claims based on the actions, omissions, or negligence of the Released Parties, whether a COVID-19 infection occurs before, during, or after Participant's participation in the event or any travel to or from the event.

11. The forgoing Waiver is intended to be as broad and including as permitted by the laws of the State of California, which shall govern the enforcement and interpretation of this Agreement, and that, if any portion thereof is held invalid, it is agreed that the resining provisions of this Agreement shall continue in full legal force and effect.
